Values at Stake

Since 1972, The United Methodist Church has codified injustice against lesbian, gay, and bisexual persons. Further destructive legislation has crept into our Book of Discipline to perpetuate harm to lesbian, gay, bisexual, transgender, queer, and intersex (LGBTQI) persons. Not only do these legislative statements do harm to individual disciples of Jesus Christ, they harm local communities, congregations, annual conferences, and indeed. the Church Universal and the Body of Christ.

The Methodist Federation for Social Action (MFSA) stands firm in its commitment to seeing the <u>removal</u> of the following: *language that declares LGBTQI

persons to be "incompatible with Christian teaching"
*bans on United Methodist clergy from acting out of pastoral care to officiate at wedding ceremonies of persons of the same sex, as well as barring congregations from hosting such weddings

*barriers for ordination of LGBTQI persons by eliminating the "self-avowed, practicing homosexual" clause *the funding ban for the advocacy of LGBTQI inclusion

Likewise, we support those pieces of legislation which bring hope and flourishing to those ministries which advocate for stronger support of ministries to persons of all sexual orientations

and gender identities within The United Methodist Church.

Conversations around LGBTQI inclusion are rightly understood through the Wesleyan lenses of Scripture, Tradition, Reason, and Experience. Because of these lenses, we know each of us comes to our understanding of sexuality and gender in unique and varied ways. While cautious about the ways the implementation of Rule 44 might harm LGBTQI persons, we place hope in the Holy Spirit for building relationships, fruitful conversation, and common understandings to make The United Methodist Church a fullyinclusive space for all who are created in the image of God.
